### New Business (7:12)

TARTA Sales Tax Proposal – Trustee Jeff Michael reported the Toledo Area Regional Transit Authority agreed Thursday to ask voters in Lucas County and Rossford to approve a 0.5-percent sales tax that will generate new revenue for the bus system, and also send some new revenue to current member local governments. The plan would eliminate TARTA's 2.5-mill property tax in the seven TARTA member communities consisting of Toledo, Maumee, Ottawa Hills, Sylvania, Sylvania Township, Waterville, and Rossford and replace it with a Lucas County-wide sales tax. One-third of the revenue, about \$10 million annually would be turned over to the Lucas County municipalities, Rossford, and Lucas County. The new funding arrangement would allow TARTA to expand service beyond the current member-community limits in county areas that area now lacking transit service, such as Oregon and Springfield Township. Neither revenue nor service will be extended to Swanton Township. The additional sales tax paid by Swanton Township residents will subsidize current TARTA members.
