#### **Old Business**

1. Resolution Objecting to the Annexation Petition Number 2025-1, annexing a portion of Swanton Township to the Village of Swanton (168.52+acres of land)

Trustee Jeff Michael reported the County Commissioners have not indicated when they will consider the petition.

2. 911 RCOG 2026 Swanton Township Proportional Share

Trustee Jeff Michael reported he filed the Swanton Township Fiscal Year 2026 Proportional Share appeal by March 10<sup>th</sup> as required. Swanton Township appealed 550 calls for 2021, 550 calls for 2022, 397 calls for 2023, and 373 calls for 2024. Over 27% of our total calls are outside our jurisdiction. For example, in 2024, 293 calls should have been billed to the City of Toledo (Airport Terminal) or the Port Authority, 34 calls to the Metroparks, and 22 calls are completely outside Lucas County.

If the appeal is approved, it will reduce our annual cost for FY 2026 from approximately \$54,000 to approximately \$39,400. This will save Swanton Township over \$14,600, just for FY2026.

Since the transfer of the 911 costs from Lucas County to the local jurisdictions, the appeals Trustee Michael submitted and worked to get approved, has saved Swanton Township over \$72,000 in the 4.5 years. Swanton Township has been the only township to have their appeals approved.
