The Fiscal Officer reported that she received a disturbing phone call from Stevens Disposal, the garbage hauler for the Township. They said an angry resident called them demanding to see the contract they have with the Township. They said they have no intention of giving it to him and they do not have to. The Fiscal Officer apologized to Stevens. She told them she was sorry that the resident did that and that it was political because the Township had a Fire Levy on the ballot. It makes no sense because the Levy has nothing to do with Stevens.

The Fiscal Officer informed the Trustees how Select Sanitation sold out to Stevens and Stevens immediately wanted to raise the rates significantly including the off weeks. It was negotiated to keep the rates affordable. However, this resident calling Stevens may hurt the Township rates and future negotiations. The Fiscal Officer reported all other townships, villages, and cities either do not offer garbage services or have a levy to pay for it. The garbage service is not paid for through property taxes but through other revenue sources, therefore the garbage service is not paid for by the residents.

The Fiscal Officer reminded everyone Swanton Township used to have pickup only one time per month, if they were lucky enough to have it picked up. The off weeks were the responsibility of the residents. We now have pickup every other week (26 pickups) and the off weeks were negotiated to be affordable for the residents.


We have returned from Executive Session at 8:14 PM. No action or voting took place while in Executive Session.
